The Governance Foundations for Not-for-Profit Directors course will provide participants with an understanding of directors' fundamental compliance and performance-related roles and responsibilities, specifically in the areas of governance, risk, financial performance and strategy.

The course is targeted to Executives, Directors and Boards of not-for-profit aged care provider organisations with an annual turnover below \$8 million.

#### 1. Introduction

By submitting your application for the Scholarship, you are deemed to have accepted these terms and conditions.

# 2. Details of the Scholarship

- ACCPA, in partnership with AICD are pleased to offer Scholarships to eligible recipients to attend AICD's Governance Foundations for NFP Directors course. To be eligible, applicants must be an Executive, Director or Board member of Aged Care organisation with annual revenue below \$8 million;
- 2.1 The Scholarship is not transferable or exchangeable and cannot be taken as cash. The Scholarship cannot be redeemed with any other scholarship, course, product or services.

## 3. General Eligibility

To be eligible to apply for the Scholarship, the applicant must at the time of application and if successful, during the Scholarship, be an individual who:

- Has the right to live and work in Australia;
- Was not disqualified from being a director of a corporation or its equivalent;
- Only one application per individual applicant will be accepted.
- Limited to one scholarship per organisation.

#### 4. Selection Process

- 4.1 ACCPA will consider the Scholarship's applications and oversee selection in liaison with the AICD.
- 4.2 The Selection Committee may in its absolute discretion decide not to grant any of the Scholarships if it considers that there are no applicants or not enough applicants who satisfy the selection criteria (minimum 12 required per course). The decision of the Selection Committee is final and no correspondence will be entered into. Scholarships will be granted following any verification of the application that ACCPA requires at its sole discretion.

### 5. Specific Eligibility

- Each successful Scholarship applicant ("Recipient") must:
- Enrol and attend the course at the Sydney or Melbourne locations upon accepting the offer of the Scholarship;
- Comply with AICD's policies and procedures as a participant of the Course.
- Satisfy himself or herself of any tax consequences;
- Comply with any additional requirements as described in ACCPA letter offering you the Scholarship.

#### 6. Submission of Applications

- 6.1 Applications should be submitted by email to <a href="mailto:david.wray@accpa.asn.au">david.wray@accpa.asn.au</a> no later than Wednesday 26 April 2023. Any applications received after that deadline date will not be considered.
- 6.2 The information provided in the application must be true and accurate as at the time of submission.
- 6.3 Please refrain from contacting ACCPA regarding your application after lodgement. All successful and unsuccessful applicants will be notified of the outcome.
